

## Parent Title IV Authorization Form






All parents are required to complete this Title IV Authorization information so that JCU can apply your Title IV funds (i.e. Direct Parent PLUS Loan) to pay open charges that your student may incur throughout the year in addition to tuition, fees, room & board.

Your **Title IV aid** will automatically pay your **current** award year institutional charges (tuition, fees, room and board) and up to \$200 of **prior** award year institutional charges.

Per Federal regulations you can voluntarily authorize that your Title IV aid to be used to pay your student's **current** term non-institutional charges such as parking and library fines, etc. You can also authorize that your aid be used to pay **prior** or **future** term non-institutional charges (with a max of \$200 for **prior** award year charges).
