#### AREAS OF EXPERTISE

#### \*Counselor Education

During a thirteen year span prior to joining the university staff full time, I taught a variety of courses with as much as a two-thirds graduate course load. I contributed to the development of new curriculum for the Chemical Dependency Counseling track by designing and teaching a three course concentration in the program. I have researched and updated the courses I teach to reflect current issues and provide opportunities for students to master the skills necessary to respond to these issues. Additional time was spent advising students in practicum experiences I supervised. I also developed and taught two courses: "Clinical Interviewing Skills" and "Counseling College Students." At the American Counseling Association in 1995, I participated in a panel presentation entitled, "Integration of a Wellness Model into Counselor Education Training."

#### \*Counseling and Psychological Services: K-12

In my role as a Pupil Services Coordinator I was responsible for coordinating a multidisciplinary team to screen referrals, assess students, and determine what course of action to take. It was my duty to maintain records on students being staffed and follow up on their progress. I was also responsible for supervising and evaluating the guidance counselors. As the Project CARE (Chemical Abuse Reduced by Education) coordinator in the Cleveland Heights-University Heights schools, I designed a comprehensive program K-12, prepared and presented the staff development programs to facilitate its implementation, revised the yearly program description, and provided ongoing evaluation, monitoring and support. The model became the design adopted by the regional Project CARE office servicing 122 school systems in 15 counties.

# \*Counseling and Psychotherapy

Over the past thirty years I have had a variety of counseling experiences with children, adolescents, and adults. About seventy-five percent of my time at the University Counseling Center was spent providing clinical supervision for counselor trainees and therapy for clients with a variety of presenting problems such as chemical abuse, eating disorders, depression, managing stress, and dealing with anxiety problems relative to development issues. Ongoing professional development has allowed me to sharpen my diagnostic, treatment planning, and therapy skills. A longtime interest of mine has been integrating spirituality into counseling. More recently I have been focusing on how the psychological processes can facilitate or restrain spiritual development.

#### \*Supervision and Training

Throughout my career I have had opportunities to design and present workshops or staff development programs on a wide range of topics to a variety of organizations e.g. decision making for the Neighborhood Centers Association, The Mc Auliffe Model on Assessment of Chemical Dependency for the staff at Glengeigh Hospital, and various other staff development programs in more than twelve area school districts as well as Page 5.

several in other states such as Oklahoma, Florida, and Illinois. A major focus of mine has been on the development of the whole person and promotion of well being. From this point of view I have consulted with agencies and groups to develop the programs I have presented. I have also planned and implemented several continuing education workshops for counselors on the family, managed care, treatment planning, shame, and anger. In my work at the University Counseling Center, I developed a structured model for supervising counselor trainees. As Coordinator for School Counseling Practicum and Supervision, I have focused on building collaborative relationships with site supervisors and the use of outcome measures in counselor training and supervision.

## \*Chemical Dependency Counseling and Prevention

Over the past thirty years I have developed a specialty in this area with the perspective of treating the family as a client. I am familiar with the full spectrum of the continuum of care: assessment, intervention, treatment, and after care. A portion of my work at the University Counseling Center involved selecting and incorporating strategies of Claudia Black, Sharon Wegscheider-Cruse, and Pia Melody into group work with clients. I have served on a staff alcoholism policy committee with the focus of identifying and referring employees exhibiting signs and symptoms of the problem. Recently, I prepared a proposal and obtained funds from Ohio Parents for Drug Free Youth for John Carroll University to participate in a consortium of 38 colleges and universities. Its purpose is to reduce the harmful effects of binge drinking on campus through an environmental approach.

# \*Career Development and Planning

A major interest reflective in my doctoral work is career counseling with a particular emphasis on eliminating sex-role stereotyping. During the seventies and early eighties I designed and implemented several workshops in Ohio, Indiana, and Kentucky, to assist counselors in combating sex bias in their delivery of career counseling services. Recently, I collaborated with Sophie Kus-Patena, Director of Academic Advising, and Cynthia Marco from the Office of Student Career Development to develop and implement a program for students who are uncertain about their choice of a major.
