

## **SUMMARY ANNUAL REPORT**

### **FOR JOHN CARROLL UNIVERSITY TAX DEFERRED ANNUITY PLAN**

This is a summary of the annual report of the JOHN CARROLL UNIVERSITY TDA PLAN, EIN 34-0714681, Plan No. 003, for the period January 1, 2015 through December 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Basic Financial Statement**

Benefits under the plan are provided through a trust fund. Plan expenses were \$2,853,002. These expenses include \$2,793,303 in benefits paid to participants and beneficiaries, and \$59,699 in administrative expenses. A total of 381 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$31,452,484 as of December 31, 2015, compared to \$30,773,992 as of January 1, 2015. During the plan year the plan experienced an increase in its net assets of \$678,492. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$3,531,494 including employer contributions of \$0, employee contributions of \$1,164,165 other income (including rollovers) of \$1,912,170, earnings from investments of \$450,169, and other income of \$4,990. There were no assets transferred to this plan during the year.
