ADMINISTRATIVE EXPERIENCE

John Carroll University. Dean of the College of Arts and Sciences (July 2015 – present). As Dean of the College of Arts and Sciences (CAS), I oversee the management of 25 academic departments and programs with over 150 full-time faculty. I also oversee the Center for Global Education, the Center for Teaching and Learning, and the Integrative Core Curriculum. Responsibilities have included strategic planning, communications, oversight of academic quality, faculty hiring, faculty evaluation and development, tenure and promotion, and personnel. Manage annual operating budget of over \$20 million.

Augustana College. Associate Dean of the College (March 2009 - July 2014). As Associate Dean, I assisted the Provost in the leadership and management of 33 academic departments and programs with 180 full-time faculty. Responsibilities over five years included strategic planning and communications, academic department and program review, faculty development, department chair development, visiting faculty hires, diversity initiatives, general education, grade appeals, academic integrity, faculty and student grievances, new program development, nationally competitive student awards, and Office of Academic Affairs personnel management and evaluation. I also served as a Title IX officer for 5 years, managed budgets for all areas of responsibility, and assisted with managing annual budget of \$25 million. I served as Provost's budget officer for academic department goods and services (2013-14).

Accomplishments as associate dean include:

- Provided oversight for 25 academic programs reviews. Fostered conversations on departments' strategic planning efforts and worked with departments to interpret and respond to assessment data.
- Chaired the task force to create our college's documentation on the Higher Learning Commission's Criterion Two: Integrity: Ethical and Responsible Conduct. Served on the steering committee to prepare for the college's next accreditation visit by the Higher Learning Commission (scheduled for 2016-17).
- Directed the process to create an interdisciplinary Public Health major grounded in Augustana's strong health sciences and liberal arts curricula.
- Headed the effort to create Augustana's first online summer courses.
- Administered all visiting faculty hires: supervised two dozen searches per year; interviewed candidates and handled contract negotiations.
- Oversaw faculty development efforts: led task force on faculty development that resulted in reimagining Augustana's faculty enrichment center; planned annual faculty retreat and year-long

- new faculty mentoring program; organized faculty development opportunities on pedagogy, scholarship, governance, and assessment spanning a range of interests and disciplines.
- Established department chairs' mentoring group to provide training, workshops, and conversation for new and experienced department chairs.
- Collaborated with multiple constituencies on campus to develop streamlined requirements for transfer students, design a new course for transfer students, and revamp our transfer student orientation.
- Partnered with colleagues at four BLAISE consortium institutions to author successful \$280,000 grant from the Teagle Foundation. The grant will fund faculty development and interinstitutional collaboration for hybrid learning classrooms over four years. The BLAISE consortium is dedicated to sharing best practices regarding the use of technology in liberal arts education, consistent with liberal arts values.
- Guided the creation of two comprehensive, interdisciplinary immersion terms (Hydrobiology and Neuropsychology) as part of a separate \$125,000 Teagle grant.

Augustana College. Chair, Department of Political Science (August 2007 - July 2009). Responsibilities included oversight of department scheduling, budgeting, evaluating faculty and staff and staff supervision.

Accomplishments as department chair included:

- Authored Augustana's first guidelines for academic program review. These were adapted unanimously by a vote of the faculty and subsequently adopted by the administration.
- Facilitated the creation of new departmental tenure standards for teaching, scholarship, and service.
- As part of a college-wide effort, created the department's Senior Inquiry program, ensuring each student would have mentored research experience in the major.
- Organized the department's first scholarship competition for prospective majors.
