Student Union Legislation-Spring 2013

As you may or may not know, the Student Union has the power to pass recommendations, appointments, and financial recommendations to the University based on their work to reach out and serve the student body. Here is a sampling of the legislation that we have passed so far this semester:

<u>REC-1-SP13:</u> A recommendation for the Late Night Swipe Program at the Inn Between, whereas students will have a set number of meal transfers, specified by Aramark, to use during a set number of hours. Passed March 26, 2013.

<u>REC-2-SP13:</u> A recommendation that Information Technology Services provide the student body of John Carroll University with access to more color printing options on campus, specifically in the Lombardo Student Center Computer Lab and the second floor Boler School of Business Computer Lab. Passed March 26, 2013.

REC-3-SP13: A recommendation to Campus Safety Services (CSS hereafter) to request a texting hotline to report criminal or possibly criminal activity. Passed April 9, 2013. REC-4-SP13: A recommendation for the Schott Dining Hall to implement a pasta bar located at the pizza station, which will alternate on a day-by-day basis with the pizza, thus providing the students with more culinary variety. Passed April 16, 2013. REC-5-SP13: A recommendation to Dr. Anne Kugler, Chairwoman of the Faculty Council, and the faculty of John Carroll University, to approve the proposed changes to the Core Curriculum as per the report of the Academic Planning Taskforce, updated April 2013. Passed April 23, 2013.

<u>REC-6-SP13:</u> A recommendation to extend the Sunday through Thursday hours of operation of the Grasselli Library and Breen Learning Center. Passed April 30, 2013. <u>REC-7-SP13:</u> A recommendation that Division of Student Affairs not eliminate a critical part of student workspace and inhibit the ability of "The Carroll News" staff to produce and deliver a superb newspaper. Passed April 30, 2013.

Student Activity Fee Information

The Student Activity Fee (SAF) is a fee paid by all undergraduate students at John Carroll University. The money from this fee is allocated to specific programs or services that directly benefit the student body, such as Student Union, the Student Union Programming Board, Greek Life, the shuttle services, and the Corbo Fitness Center. The amount of these allocations are determined by the Student Activity Fee Allocation Committee (SAFAC) made up of the SU VP of Business Affairs, one SU Senator, one Student-At-Large, and

three student affairs administrators.

One line item of the SAFAC allocations is the funding for the Student Organization Budget Board, which is chaired by the SU VP for Student Organizations. Throughout the fiscal year, the Budget Board meets to allocate funding to recognized student organizations, based on their requests. Money that is unused or unallocated from the SAF money collected from students, is placed in one account at the end of the fiscal year (which runs June 1-May 31). After the fiscal year ends, SAF supervisors have the opportunity to request money from the pool of unused and allocated funds for special projects that direct-

In our April 16 Student Union Meeting, as per Constitutional requirement, the Student Union was presented with 3 financial recommendations: A bill to approve the proposed SAFAC allocations for FY14, a bill to approve the proposed Student Union budget for FY14, and a bill to approve the Student Union Programming Board budget for FY14.
