How to Apply

Applicants with disabilities may be eligible for a special non-competitive appointment known as "Schedule A" hiring authority. To be eligible, you must have a psychiatric, intellectual or severe physical disability. Schedule A eligible applicants can prove their eligibility by providing documentation from licensed medical professionals, state or private vocational rehabilitation specialists, or any government agency that issues or provides disability benefits.
